CODE OF CONDUCT

The 2024 Community Violence Intervention (CVI) Conference is dedicated to providing a safe, inclusive, and productive environment for all attendees, fostering collaboration and a sense of community among those committed to reducing violence and promoting peace. We strive to create a welcoming atmosphere for everyone, regardless of gender identity, sexual orientation, race, ethnicity, immigration status, religion, disability, physical appearance, and career level, among other attributes. All individuals participating in the conference, in any capacity, are expected to adhere to this Code of Conduct. This Code of Conduct applies to all aspects of the conference experience, including events organized by third parties in conjunction with the CVI Conference, regardless of location or setting.

Expected Behavior

- 1. Treat all individuals with respect and empathy, recognizing the vulnerability and courage required to engage in discussions about violence.
- 2. Practice active listening when others share personal stories and experiences to cultivate a safe space for open dialogue that embraces humility, openness to learning, and adherence to the values reflected in the conference code of conduct.
- **3.** Foster a spirit of collaboration and mutual support among attendees from diverse backgrounds, disciplines, and perspectives.
- **4.** Engage in respectful and constructive discussions, focusing on issues and ideas rather than individuals, and be mindful of the impact of your words and actions on others.
- 5. Adhere to the rules and policies of the conference venue, hotels, and any other associated locations.

Unacceptable Behavior

- 1. Any form of harassment, intimidation, or discrimination, whether verbal, physical, or written, is prohibited. This includes sexual harassment, which refers to unwelcome sexual advances, comments about physical appearance, repeated requests for a date, and other forms of verbal or physical conduct of a sexual nature.

The Intersection of Victim/Survivor Services and CVI

Salon 1

Antiquated and discriminatory policies have created significant challenges for integrating victim services with community violence intervention. This session details the harms caused, explores advocacy opportunities for interventionists, and examines real-world case studies from Los Angeles, Newark, and Maryland. Panelists will share best practices for enhancing support for survivors, discuss proposed federal rule changes, and provide actionable insights and strategies for strengthening victim services within CVI initiatives.

I Want the Help to Look Like Me: The Development and Implementation of a Culturally Responsive Peer Healing Model

In Baltimore, a virtual peer healing model is transforming the lives of Black male survivors of violent injury. Unlike traditional facilitator-led peer support, this model empowers participants to guide their own healing process. Referencing focus group data and digital storytelling from an 18-week program, panelists will discuss how to use peer healing circles to foster autonomy and healing, as well as the model's potential to revolutionize support systems for survivors of violent injury.

Nurturing Transformation: A Workshop on Collective Healing and Post-Traumatic Growth

This workshop, led by experienced practitioners in gang intervention, re-entry services, and restorative practices, aims to equip participants with tools for effective self-care and collaborative models within the justice system. Attendees will also explore a phenomenological approach to working with gang-involved and system-impacted individuals. The session will focus on cultivating collective healing and encouraging post-traumatic growth, emphasizing the transformative power of communities in overcoming adversity and trauma.

Community Violence and Firearm Injury Prevention Communication through a Public Health Lens

Previewing the Department of Justice's Investments in CVI

Innovations in Street Outreach

This training, led by CRED's outreach team, will highlight effective approaches to key topics such as canvassing, recruitment, intake, maintenance, mediation, and developing non-aggression agreements. Attendees will learn how to use data analytics and community mapping to identify needs, mediate conflicts, and sustain peace in high-risk areas.

Serving "Healing" to South Central Los Angeles: CVI Partnerships & Collaborations

This presentation emphasizes solidarity and collaboration for lasting change in South Central Los Angeles, spotlighting two nonprofits dedicated to gang intervention and community healing. Panelists will discuss the history, mission, services, and partnerships of these organizations as they work together to establish safe spaces, cultivate alliances, and educate on the root causes of violence with the shared goal of empowering communities through unified efforts.

This session examines the pathways of youth involved in both systems and highlights how cross-sector collaboration can minimize harms caused by these systems. This session introduces Scaling Safety, a first-of-its-kind initiative co-led by Alliance for Safety and Justice and the Community-Based Public Safety Collective that aims to enhance the capacity of cities facing chronic violence to build robust, community-centered safety infrastructure through effective programs, integration into existing public safety frameworks, and comprehensive technical support.

Intimate partner violence and community violence are often treated as separate issues, despite their shared risk factors and disproportionate impact on marginalized communities. This session explores the intersections between IPV and community violence, highlighting the challenges in understanding their prevalence and the need for a broader conversation within CVI. Attendees will learn about strategies to identify and address these intersections, enhancing safety for those at the highest risk of harm.

Building Partnerships to Heal Victims of Community Violence

In Connecticut, a new partnership is redefining care for victims of community violence beyond medical intervention. From bedside to wraparound support, St. Francis Hospital, COMPASS Youth Collaborative, and the UConn Department of Family Medicine are working together to meet the holistic needs of violently injured individuals. This session will explore how the partnership engages victims, deploys crisis response teams, and creates safe healing environments that work to promote complete physical and emotional recovery.

Healing the Healers

How City Leads Champion the CVI Ecosystem in Comprehensive Public Safety Plan Development

City leads are key champions who have the ability to bridge the gaps between community-based organizations, government institutions, and advocates by identifying collaborative solutions to uplift in a healthy CVI ecosystem. This workshop, led by Cities United, a network of mayors and their teams committed to reducing homicides of young Black men and boys by 50%, will explore the need for transparent partnership in violence reduction.

Meeting Youth Where They Are: Bringing Violence Prevention and Intervention Resources to Schools in Oakland

This presentation explores Oakland's School Violence Intervention and Prevention Program, which places specialized teams in high schools to address students affected by violence. Staff funded by the City of Oakland and employed by community organizations deliver programming that includes case management, support groups, conflict mediation, and staff education. Participants will hear about strategies for effective implementation and engage in a facilitated discussion, seeking to reimagine school safety with minimal law enforcement involvement.

During program implementation, there is always a risk of unexpected changes. This session discusses pivoting mid-course to address evolving violence landscapes, legal frameworks, and methodological advancements. Through examples from Haiti, El Salvador, and Honduras, panelists highlight a common theme: a community-centered approach that is guided by listening to community needs and reorienting programs accordingly. Participants can expect to learn valuable lessons in adapting CVI initiatives to effectively respond to shifting circumstances.

PAUL CARRILLO

Vice President, GIFFORDS Center for Violence Intervention

Paul Carrillo is the vice president of GIFFORDS Center for Violence Intervention. He was raised in Southeast Los Angeles in an environment with gangs, drugs, and gun violence. In 2001, he began his career as a volunteer for a hospital-based violence intervention program, and in 2005 he co-founded Southern California Crossroads, a nonprofit that provides violence prevention and intervention services throughout the greater Los Angeles region. He has also consulted on community violence internationally in Guatemala, London, the Dominican Republic, Ireland, Tunisia, St. Kitts and Nevis, and El Salvador.

Melvyn Hayward oversees the Gang Reduction & Youth Development (GYRD) department in the Los Angeles Mayor's Office of Community Safety. GRYD partners with local nonprofit agencies providing intervention and prevention services in 23 GRYD zones. Prior to joining the mayor's office, Melvyn was the chief program officer at Chicago CRED. Additionally, Melvyn has served as a CVI practitioner for 26 years and has traveled to 30 cities throughout the US in order to train outreach workers, develop best practices, and provide technical support to several CVI agencies.



DR. ANDREW PAPACHRISTOS

Faculty Director of the Center for Neighborhood Engaged Research & Science (CORNERS)

Dr. Andrew Papachristos is a professor of sociology at Northwestern's Institute for Policy Research and the faculty director of CORNERS: the Center for Neighborhood Engaged Research & Science. He is a Chicago native and one of the world's leading experts at applying network science to the study of crime, violence, policing, and urban neighborhoods. Dr. Papachristos has over 15 years of experience working with community groups, state and local agencies, schools, hospitals, city governments, and the federal government. His methods have been widely cited as models for engaged research and evaluation in the area of community violence.



EDDIE BOCANEGRA

Senior Advisor to the Assistant Attorney General of the Office of Justice Programs Eddie Bocanegra, a senior

advisor in the Office of the Assistant Attorney General, is a leading figure in the field of community violence intervention. He oversees a portfolio focused on preventing and responding to community violence, making him a key member of the Biden administration's efforts in reducing gun violence. Before joining the Department of Justice in 2022, he served as the senior director of READI Chicago at Heartland Alliance. A pioneer in the field, Eddie is nationally recognized for his work as a violence interrupter with Chicago's Ceasefire program.



MANNONE BUTLER

Head of Programs & Partnerships at the NBA Social Justice Coalition

Mannone Butler is head

of Programs & Partnerships for the National Basketball Social Justice Coalition (SJC), the policy advocacy arm of the NBA community formed in 2020 to address racial inequality and advance social justice. She leads the development and implementation of the coalition's policy agenda, partnership and stakeholder engagement strategies, and day-to-day operations. Previously, Mannone spent 11 years leading the Criminal Justice Coordinating Council for the District of Columbia (CJCC), an independent justice agency responsible for crafting solutions to public safety issues in the nation's capital.



EMMA BROWN

Executive Director of GIFFORDS

Emma Brown became the executive director of GIFFORDS in January 2024, where she oversees the organization's work

to save lives from gun violence. Prior to leading GIFFORDS, Emma served as campaign manager for Senator Mark Kelly's 2022 reelection campaign in Arizona. In 2020, Emma served as the coordinated campaign director for President Biden's campaign in Arizona, leading the largest voter contact program in state history and marking the first time a Democratic presidential campaign carried Arizona since 1996. During that cycle, she also served as Senator Kelly's deputy campaign manager.



GABRIELLE GIFFORDS

Former Congresswoman and Founder of GIFFORDS

A former congresswoman from Arizona, Gabby Giffords

was a rising star in the Democratic party before she was shot in the head in January 2011. As the founder of GIFFORDS, an organization dedicated to ending gun violence, Gabby believes in the power of bringing people together to create meaningful change—and she knows just how important CVI is to fighting the epidemic of gun violence. GIFFORDS launched its Center for Violence Intervention in 2022, which champions the lifesaving work of community organizations on the ground, and Gabby is committed to using every tool available to end America's gun violence crisis.

support services and engaging

in communities most impacted by trauma. As a Bay Area native, Kenny believes that the lived experience he has as a high-risk youth and young adult has given him the tools needed to affect real change in his community.



GABRIEL GARCIA

Gabriel Garcia currently serves as the policy and advocacy director for Youth ALIVE!, a community-based organization in Oakland focused on preventing and helping people heal from violence. In building

out Youth ALIVE!'s policy and advocacy work, Gabriel ensures those closest to the pain are driving policy conversations that improve California's ability to treat violence like the public health crisis that it is. In the last year, YA clients have testified in state legislative hearings and led conversations with elected officials to demonstrate how they can use their positions to help those who have been most harmed by violence.

to make our nation's gun laws safer, create jobs, provide affordable healthcare to all Americans, and articulate a forward-looking foreign policy. Senator Murphy was the lead negotiator of the Bipartisan Safer Communities Act, which broke a 30-year political logjam on gun safety legislation and was signed into law by President Biden in 2022.

Kim now leads campaigns with a team of state advocacy leaders to drive increased investments in public health approaches to gun violence at the national, state, and local level.



FERNANDO REJÓN

Fernando Rejón is the executive director of the Urban Peace Institute, leading its efforts to transform systems and individuals' lives by promoting community peace and ending mass incarceration. In 2008,

Rejón created the Urban Peace Academy, training leaders nationwide on violence reduction strategies and gang intervention. He advises law enforcement on innovative policing strategies and co-created the National Street Outreach Partnership. With 18 years of nonprofit experience, Fernando excels in program development, community-based research, and coalition building.



VAUGHN BRYANT

Vaughn Bryant is executive director of Metropolitan Peace Initiatives (MPI), a division of Metropolitan Family Services that features a team of professionals working in partnership with community-based and

citywide organizations to coordinate, support, and sustain comprehensive services designed to heal communities that have experienced the highest levels of gun violence. Vaughn previously held leadership roles with the Chicago Park District, Chicago Public Schools (where he developed the "Safe Passage" program), the NFL, and Stanford University. A graduate of Leadership Greater Chicago, Vaughn serves on the National Advisory Board of the Haas Center for Public Service at Stanford University and on various committees with the Chicago Community Trust.

In her current role, LaQuay oversees supportive programs and services for community violence participants involved in the Chicago CRED program.

As the intervention programs director at Youth ALIVE! and an Oakland native, Paris Davis oversees the strategic planning of the organization's intervention programs to ensure their effectiveness. His role

involves managing operations and developing growth strategies, and he works closely with teams to provide necessary resources, training, and support for impactful community prevention and intervention. Additionally, he leads program development and continuously seeks to enhance services based on community needs. Committed to driving positive change, Paris focuses on expanding the organization's reach, forging new partnerships, and implementing innovative strategies to improve outcomes for those they serve.



ARMANDO TORREBLANCA

Armando Torreblanca, an innovative and driven organizational architect, serves as the associate executive director at Project Hope CA, a Pomona-based

nonprofit specializing in reentry services. With more than a decade of experience in community violence intervention, he played a pivotal role in transforming the organization from a volunteerled group in 2018 into a thriving nonprofit with multiple programs. His dedication to cultivating positive organizational culture, enhancing employee engagement, and championing peoplefirst leadership has been central to his work.




